- * Saturdays falling on 16th July and 3rd December have been kept as alternative Court sitting days in the event of declaration of any unforeseen holiday(s). The cases fixed on such unforeseen holiday(s) may be taken up on these days or as may be notified. However, the case(s) wherein orders/judgments are reserved shall be taken up on the next working day immediately following the date, which has been declared as additional holiday.
- Holidays common to the High Court and Courts Subordinate to it have been shown in half red and half green squares and those shown in red squares will be observed exclusively by the High Court.
- All Sundays and second Saturdays have been shown in red colour. Local holidays i.e. 16th Apr, 12th Aug, 30th Sept, 29th Oct & 7th Nov and fourth Saturdays, as shown in red squares, will be observed exclusively by the High Court. 17th & 19th Mar, 10th Aug, 29th Sept, 4th & 21st Oct will be observed as Local holidays by the High Court and the Courts Subordinate to it.
- The High Court will remain closed for Summer Vacation from Saturday, 4th June to Friday, 1st July (both days inclusive) and for Winter Vacation from Monday, 26th December to Saturday, 31st December (both days inclusive).
- The Subordinate Courts (except the Courts of Metropolitan Magistrates) in Delhi will remain closed for Summer Vacation from Monday, 13th June to Thursday, 30th June (both days inclusive) and for Winter Vacation from Monday, 26th December to Saturday, 31st December (both days inclusive).
