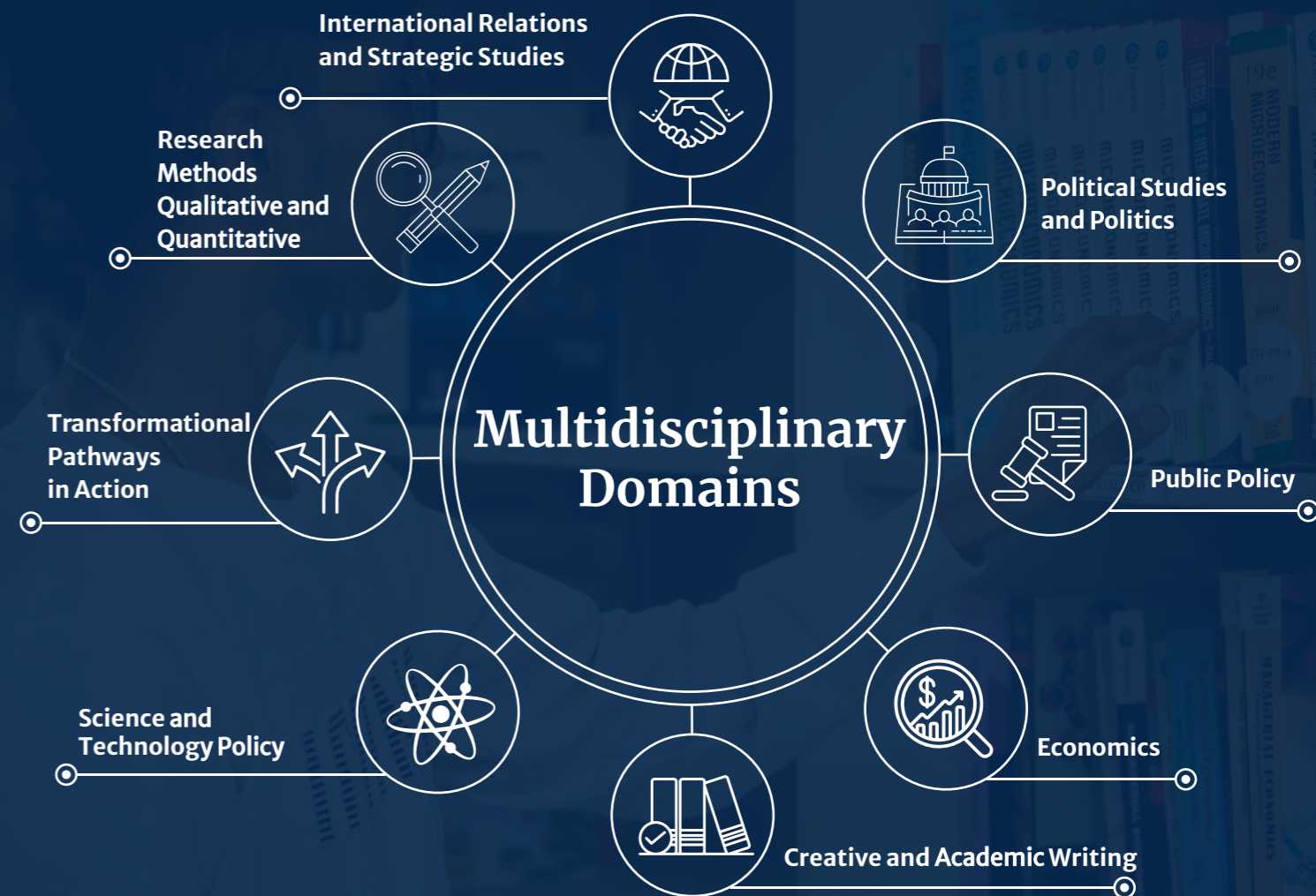

The objective of the Transformational Pathways in Action Module (TPAM) will be to provide students with exposure to the real world at the premises of the host organization or remotely.

The Transformational Pathways in Action Module (TPAM) will entail the following.

- The host organization/institution provides a detailed orientation to students about the topic/problem statement and/or roles/responsibilities.
- After the orientation phase, students are associated with the mentor to carry out the assignment.
- All students will submit a copy of the final report to the host organization and another copy to the University.
- The duration of the experiential learning module will be for about 6 weeks.

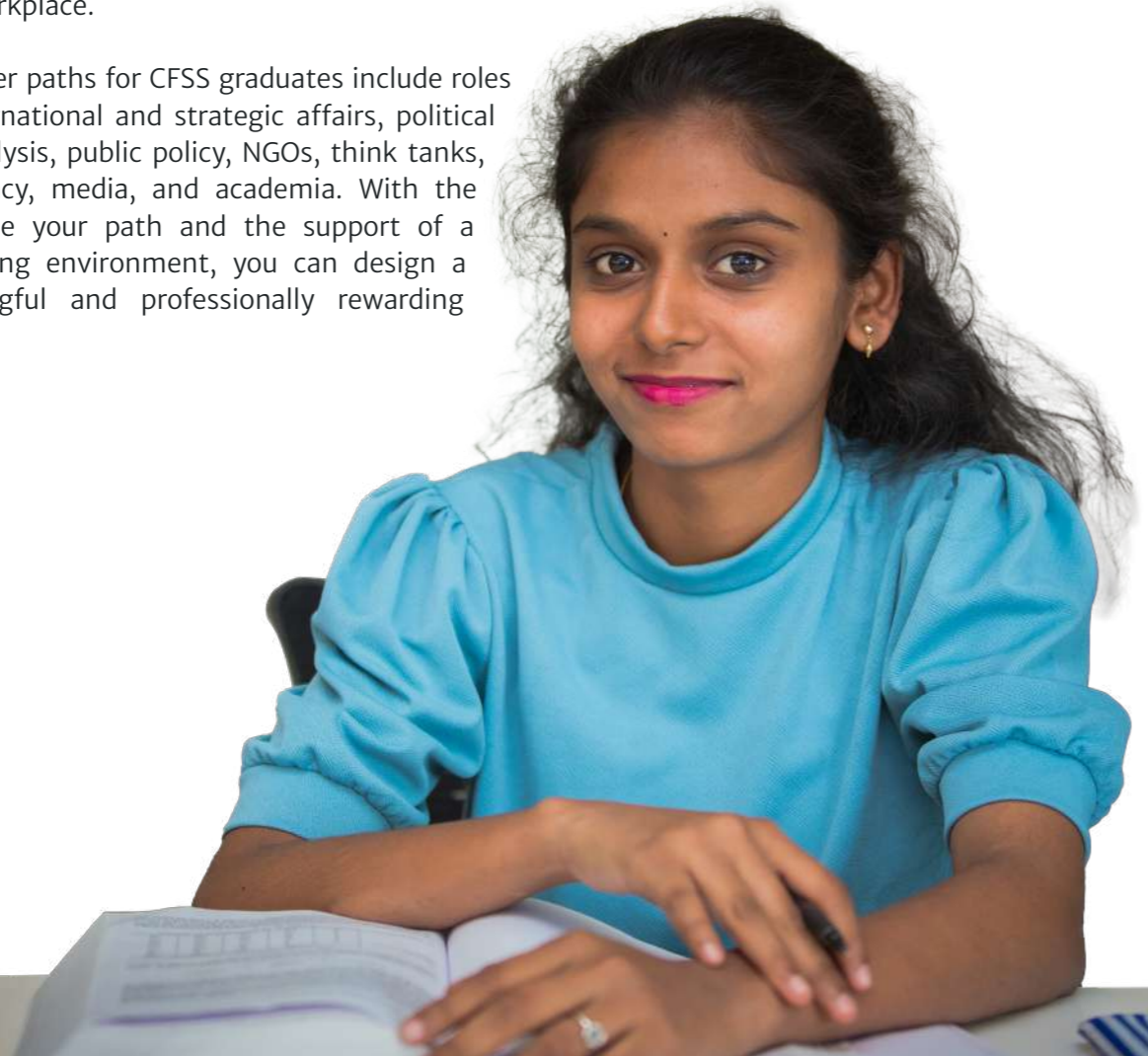

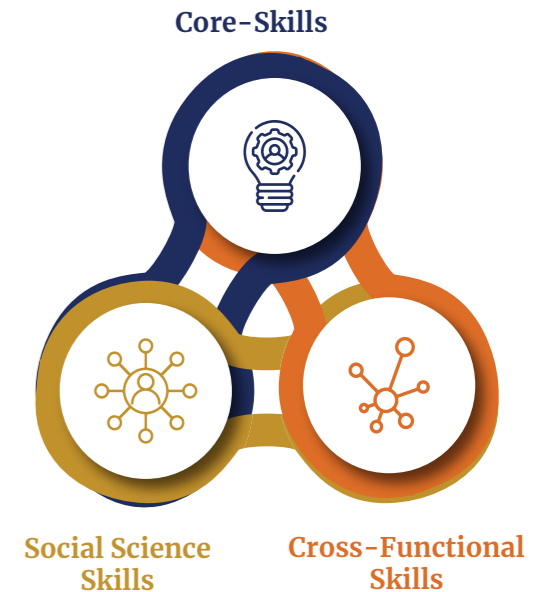
Build Skills To Get Recruited

Core Skills:

Political Science: knowledge of political systems and structures, research and analytical skills, familiarity with political theory and ideology, understanding of public policy and decision-making processes, critical thinking and problem-solving skills, strong written and verbal communication skills, interpersonal skills for effective networking and relationship-building.

Economics: understanding of macroeconomic and microeconomic principles, ability to analyze economic data and draw conclusions, knowledge of financial markets and institutions, familiarity with econometric analysis and statistical software, strong quantitative and analytical skills, ability to conduct research and synthesize information, effective communication and presentation skills.

International Relations: knowledge of global politics and diplomacy, familiarity with international organizations and institutions, understanding of foreign policy and national security issues, ability to conduct cross-cultural analysis and research, strong written and verbal communication skills, analytical skills to assess political and economic risks, interpersonal skills for effective networking and relationship-building.



Cross-Functional Skills:

- Communication: strong written and oral communication skills
- Critical thinking: the ability to analyze complex information, identify patterns and trends, and make sound judgments based on evidence.
- Problem-solving: adept at identifying and solving complex problems
- Research: trained in research methods and data analysis
- Interpersonal skills: possess strong interpersonal skills, which enable them to build relationships and work effectively with colleagues and clients.
- Adaptability: equipped with the ability to adapt to changing circumstances and environments
- Additional skills that social science graduates may find valuable in the workplace: data analysis, digital literacy, project management, intercultural competence, entrepreneurship, sales and marketing, marketing and branding, innovation and creativity, emotional intelligence, research skills, knowledge of policy and governance, cross-cultural competency, strategic thinking, and problem-solving.

To be eligible to apply for the Chanakya Fellowship Programme intake:

- Applicants should have completed a undergraduate degree or equivalent in any discipline as of July 2023 from a recognized university
- We welcome applicants of all age groups across diverse academic, geographical, professional and socio-economic backgrounds.

Note: Final-year students, working professionals, postgraduate or doctoral degree holders, entrepreneurs, freelancers, and those in the middle of a gap year or preparing for competitive examinations, among others – are all eligible to apply.

Scholarships/Financial Aid

Chanakya University has been providing scholarships to ensure diversity, belongingness, and inclusion.

In line with this, the Chanakya Fellowship in Social Sciences (CFSS) awards scholarships on the basis of merit as well as financial need, and in some cases, a combination of both. We understand that financial challenges can make it difficult for students to pursue their academic goals, which is why we aim to help deserving students by providing need-based scholarships.

Some recipients of the scholarship may receive a complete tuition and hostel fee waiver, depending on their circumstances. This means that they will not have to pay any fees for their tuition or accommodation.

If you are interested in applying for the CFSS scholarship, we encourage you to submit a high-quality essay (the optional 300-word scholarship essay) that showcases your academic achievements, financial needs, and any relevant personal or community achievements.

We hope that this scholarship will help make higher education more accessible to students who may be facing financial barriers and help them achieve their academic goals.



Admission Criteria

Applicants are selected through a holistic admission process conducted over two rounds based on supplemental application, statement of purpose, and interview.

Applicant Profile

The Chanakya Fellowship in Social Sciences program is looking for candidates who can harness their academic and professional competencies. Individuals who we believe can use the learnings from the fellowship in synergy with their existing qualifications and aspirations to enable myriad pathways for their life. The key traits we look for in a candidate include passion, commitment, creativity, and critical thinking. Fellows will be expected to show the utmost dedication to the program and complete all coursework and projects for the fellowship period.

Applications are invited from a cross-section of disciplines. An ideal applicant is one who demonstrates a drive to succeed individually and collaboratively. We seek fellows who demonstrate the potential to be a leader in fields such as academia, corporate careers, social entrepreneurship, media, bureaucracy, technology, civil society and politics among others. Through active classroom participation, fellows will be able to leverage peer learning to facilitate multi-disciplinary understanding.

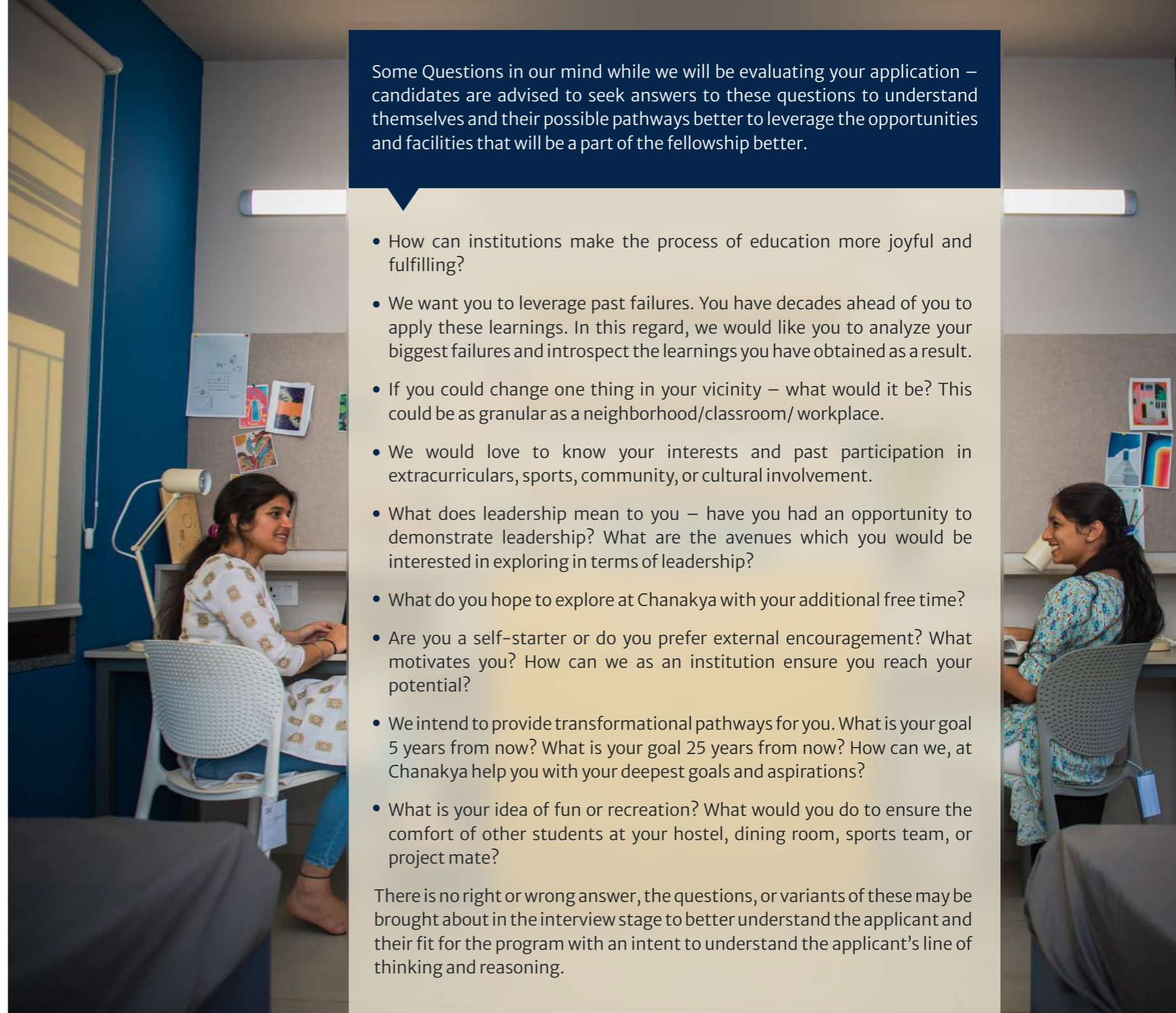
The application form aims to assess the candidate on the following parameters:

- **Past Academic Record** – Since this will be a rigorous program which will be academically demanding, a candidate's past academic credentials will be evaluated. However, this will be one of several parameters which will be evaluated.
- **Adaptability**– Ability to work with diverse teams with different ideologies and worldviews and respect cognitive diversity.
- **Stakeholder Management** – Ability/Interest in working with a cross-section of stakeholder groups
- Ability to take the initiative and demonstrate Leadership qualities
- Passion/Commitment towards society at large and drive to succeed.

Some Questions in our mind while we will be evaluating your application – candidates are advised to seek answers to these questions to understand themselves and their possible pathways better to leverage the opportunities and facilities that will be a part of the fellowship better.

- How can institutions make the process of education more joyful and fulfilling?
- We want you to leverage past failures. You have decades ahead of you to apply these learnings. In this regard, we would like you to analyze your biggest failures and introspect the learnings you have obtained as a result.
- If you could change one thing in your vicinity – what would it be? This could be as granular as a neighborhood/classroom/ workplace.
- We would love to know your interests and past participation in extracurriculars, sports, community, or cultural involvement.
- What does leadership mean to you – have you had an opportunity to demonstrate leadership? What are the avenues which you would be interested in exploring in terms of leadership?
- What do you hope to explore at Chanakya with your additional free time?
- Are you a self-starter or do you prefer external encouragement? What motivates you? How can we as an institution ensure you reach your potential?
- We intend to provide transformational pathways for you. What is your goal 5 years from now? What is your goal 25 years from now? How can we, at Chanakya help you with your deepest goals and aspirations?
- What is your idea of fun or recreation? What would you do to ensure the comfort of other students at your hostel, dining room, sports team, or project mate?

There is no right or wrong answer, the questions, or variants of these may be brought about in the interview stage to better understand the applicant and their fit for the program with an intent to understand the applicant's line of thinking and reasoning.



Application Process

Two-stage application process.

The Application process aids the candidate in self-discovery. Any claims made during the application must be backed with examples, wherever applicable. While English will be the medium of instruction and the application, however, the quality of English will not be a factor in the application. Chanakya University aims to ensure candidates from varied socio-economic backgrounds apply to the CFSS.

Stage 1

- To register, please scan the QR code located on the back and proceed to submit the form or visit <https://chanakyauniversity.edu.in/registration/>
- Applicants will receive a confirmation email.
- Fill background information, education, current role, and related information
- The candidate shall submit a detailed CV/resume, a statement of purpose (about 500 words), and an essay (max 500 words).
- Optional writing brief (max 200 words) for candidates to convey any other essential information.
- Applicants for scholarships are required to share a 300-word essay to substantiate.

Stage 2

- A personal interview will be conducted based on the information provided by the applicants, the interview may also entail relevant topics as decided by the panel to determine the fit of the candidate.
