SUBMISSION GUIDELINES:

- ❖ Submission of paper indicates that it has not been copyrighted, published or submitted or accepted for publication elsewhere.
- ❖ The journal invites original and unpublished contributions.
- ❖ Manuscripts should normally be of around 2500-3000 words (typed single space, Times new Roman, Font 12).
- ❖ All the manuscripts should include an abstract of about 250 words.
- ❖ No abstract is required for case laws reviews, book review or case study.
- ❖ Foot notes should mention only those sources actually cited in the text or notes. Author name should be same as in the original source.
- ❖ Tables/ Figures should be placed at the proper place of the text. Tables should contain a sources and units of measurements.
- ❖ Quotes should be cited accurately from the original source, should not be edited, and should give the page numbers of original publication.
- ❖ Capitalization should be kept the minimum and consistent.
- ❖ Book reviews must provide the following details, and in this order:
 - Name of author
 - Title of book reviewed
 - Place of publication/ name of the publisher
 - Year of publication
 - Number of pages in Roman figures to include preliminary pages and price, with binding specifications such as paperback or hardbound.

The papers will be sent to the reviewers committee for their review process. After review process, the reviewer committee shall recommend whether a paper is accepted or rejected or to be resubmitted with significant changes. The text paper must be according to specific guidelines

and in the document format. The Full text papers will be accepted in only document format and should be e-mailed to: iimtlawjournal@gmail.com.
