
CIRCULAR

Applications are invited for filling up the post of **Joint Registrar** in the **Armed Forces Tribunal, Regional Bench, Chandigarh** on **deputation basis** for a period of three years from suitable candidates, who fulfill the eligibility conditions:-



2. The pay of the officer selected on deputation basis will be governed by DoP&T O.M. No. 6/8/2009-Estt(Pay-II) dated 17.06.2010, as amended from time to time.
3. The departmental officers in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion.
4. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall not ordinarily exceed **four years**. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.
